

OTT Platform Revenue Share Agreement

This Agreement is made on __20th March 2026 ___, by and between:

- **Platform Owner: VideoOTT.online**, having its **Registered Office** at DLF Corporate Greens, 1812, 18th Floor, Sector 74A, Gurgaon, Haryana, India and **Administrative Office** at 3rd Floor, A83, A Block, Sector 63, Noida, Uttar Pradesh India.

1. Purpose

The purpose of this Agreement is to define the terms under which the Content Partner will provide audiovisual content to the Platform Owner for distribution via *videottt.online*, and the revenue generated will be shared between both parties.

2. Definitions

- **Content:** Films, series, shows, or other audiovisual works provided by the Content Partner.

- **Rights on Content : Digital for OTT only.**
- **Gross Revenue:** Total revenue generated from subscriptions, pay-per-view, advertisements, or other monetization methods.
- **Net Revenue:** Gross Revenue minus applicable taxes, payment gateway charges, and platform fees.

3. Rights & License

- The Content Partner grants the Platform Owner a **non-exclusive license** to host, stream, and distribute the Content on *videottt.online*.
- The Content Partner retains all intellectual property rights in the Content.

4. Revenue Sharing

- Revenue shall be shared on a **[percentage split, e.g., 60:40]** basis between the Platform Owner and the Content Partner.
- Settlement of revenue shall occur on a **quarterly** basis.

- Detailed reports of views, subscriptions, and revenue shall be provided to the Content Partner.

5. Obligations of the Parties

• Platform Owner:

- Ensure secure hosting and streaming.
- Provide transparent reporting of revenue.
- Handle customer support and technical infrastructure.

• Content Partner:

- Deliver content in agreed formats and quality.
- Ensure content is free from third-party claims, piracy, or legal disputes.
- Promote content jointly with the Platform Owner.

6. Term & Termination

- This Agreement shall remain valid for **[3 years]** unless terminated earlier.
- Either party may terminate with **[60 days]** written notice.
- Breach of terms, copyright violations, or non-payment may lead to immediate termination.

7. Confidentiality

Both parties agree to maintain confidentiality of financial data, user analytics, and proprietary information.

8. Governing Law & Jurisdiction

This Agreement shall be governed by the laws of **India**, and disputes shall be subject to the jurisdiction of courts in **[Noida - Uttarpradesh]**.

9. Miscellaneous

- Any amendments must be in writing and signed by both parties.
- Force Majeure clause applies in case of unforeseen events beyond control.
